IN ADDITION, WE'VE ACHIEVED MAJOR POLICY VICTORIES THAT INCREASE ACCESS TO CARE, MOBILIZED PATIENT ADVOCATES TO CALL FOR CHANGE, AND EDUCATED PEOPLE NATIONWIDE ON CRITICAL HEALTHCARE-RELATED TOPICS. WE'RE COMMITTED TO WORKING TOWARDS A FUTURE WHERE EQUITABLE HEALTH OUTCOMES ARE A REALITY FOR ALL.
